The current equipment is being offered for free, and it is asked if interested parties would like to be added to the list. The Councillors agreed for CPC to be added.

9 **COUNCILLORS REPORTS**

Cllr. Mcallister reported in the last meeting that the overgrowth on the footpath through the golf course to Great Shefford has now been cut, no further action required.

Cllr. Mills asked if Council would consider paying £65.00 for the cleaning of the Jubilee shield which has been placed on the Ibex outside wall as a commemorative of the Jubilee. Councillors **RESOLVED UNANIMOUSLY** to approve the payment.

Cllr. McNamara reported the verges need cutting in RG20 7DX and RG20 7DY. Cllr. Hooker, in attendance said the grounds maintenance team are behind on their schedule and are low on resources, Cllr. Hooker said he would prompt them, and the Clerk will also send an email to them.

Cllr. Mcallister reported that he had cleared the foliage from the signs at the bottom of School Hill and Main Street. He also said he would cut the branches back in the playground around the junior climber. The Parish Council thanked Cllr. Mcallister.

Cllr. Murphy asked the Clerk to chase up the verges at The Butts and Mount Lane, some work had been carried out, but this needs completing. The grips were identified a while back, but so far nothing has happened.

Cllr. Murphy reported that a resident said at the bottom of Cross Pitts cottage on the junction at Sheep House Road is very uneven. This was reported to West Berkshire Council.

Cllr. Hooker, ward member reported that most parishes have the same issues, regarding speeding and overgrowth. This year's Members Bid's did not have much of an uptake this year with match funding. In May 2023 bids will be offered again and asked Councils to keep this in mind for any projects in the parish that could be match funded.

Cllr. Hooker's position as Chairman to West Berkshire Council came to an end in May and he reported that it had been a pleasure and privilege to serve as Chairman and on behalf of the Downlands ward.
